What two months ago was an exciting time for our organization, getting prepared for an excellent scientific conference program to be held in Tampa, has become a time of hardship, fear, uncertainty, stress, and definitely a bit of boredom. # **ANIMAL CARE IN THE TIME OF COVID-19**

I'm sure we have all seen videos of penguins, seals, and even armadillos "exploring" empty zoos and aquariums or of unique enrichment for and around animals including musicians playing near the beluga habitat at Mystic Aquarium. We've also seen the media of wild animals wandering in areas typically filled with people.

Many zoos and aquariums around the world have been closed for two to several months due to the current COVID-19 pandemic. As we often jokingly say, many of the animals don't "care" about the changes around them. They still require food, housing, and enrichment just like all of us. These closures have allowed and/or required facilities to change-up animals' daily routines, offer different enrichment items or events, and sometimes focus on behaviors that may previously have been considered a lower priority. One great example comes from Aquarium du Québec. A macaw which had been strongly bonded to a certain staff member has become more comfortable with other staff who are spending more time with him. Also, some undesirable behaviors that are often inadvertently reinforced by guests are decreasing without the attention. Facilities are also noticing behavioral changes due to quieter days in some of the more reclusive species (the introverts of the animal world). Some of the birds at South Carolina Aquarium have been out and about more, and the potbellied seahorses at Aquarium du Québec are breeding in the exhibit. Of course, just as with people, animals react differently to decreased human presence and other altered external stimuli. Species or individuals that thrive on frequent physical or mental stimulation (the extroverts if you will) are re-directing their attention, resulting in increased intraspecific interactions and decreased food motivations among some cetaceans and various fish species. Sumida Aquarium in Tokyo, Japan has urged people to video call their garden eels after the animals began avoiding staff. Animal Care staff at Gulf World Marine Park have been utilizing this time to strengthen bonds between individual animals by altering training sessions and between staff and animals by increasing water works and other varied interactions (including an impromptu personal 20 minute session playing catch with a few dolphins recently).

Some rescue and rehabilitation centers have also either closed or decreased response to stranded animals and some express concern of reduced citizen response due to closed beaches and waterways. However, significantly fewer incidences of wildlife harassment are being reported and animals are even being observed expanding their range onto the closed beaches, parks, and city streets.

Despite mounting obstacles including decreased staffing due to furloughs and layoffs, and concerns for consistent food and medications due to backorders, lack of supply, or diminishing funds while closed, as well as increased protective contact via PPE or distancing to reduce zoonotic or human-human disease transmission, the animal care and veterinary teams at zoos and aquariums, rescue and rehabilitation centers, veterinary schools and aquaculture facilities around the world continue to provide the same high standard of care. Two of the greatest reminders that I have had during this challenging time are that we truly do this work for the love of the animals, and that we are here for each other through good times and tough times, even if it's in a virtual format.

Thank you to my IAAAM family for just being you!

# Nominee for President-Elect: Dr. Tonya Clauss

Dr. Tonya Clauss has been a member of IAAAM since 2000. She has served as the IAAAM Treasurer since 2015 and has been a member of the Student Liaison Committee since 2004. Clauss is currently the Vice President of Animal & Environmental Health, at Georgia Aquarium, where she has worked for 15 years. She received dual bachelor's degrees in Animal Science and Wildlife Ecology & Conservation from the University of Florida, with a minor in chemistry. In 2003, she received her doctorate in veterinary medicine from the University of Florida, College of Veterinary Medicine and was awarded the Learner Family Wildlife Conservation Award for excellence in wildlife and zoological medicine. In 2004, she finished a master's degree in Environmental Engineering Sciences with a focus on Wetland's Ecology. After graduation from veterinary school, Clauss accepted a position as staff veterinarian at the Mote Marine Laboratory and Aquarium in Sarasota, Florida. In early 2004, she was hired as director of veterinary services for Pelican Man's Bird Sanctuary, a wildlife rehabilitation facility also in Sarasota. While at this position, Clauss became a research affiliate at The Florida Aquarium in Tampa, a position she held until December 2007. In February 2005, Clauss began working at the Georgia Aquarium as an associate veterinarian and assistant manager of veterinary services and has worked her way up the supervisory chain over the years. In 2009, she received a University of Florida, Outstanding Young Alumni award for her early career achievements in Animal Health. Clauss enjoys teaching up and coming veterinarians and is a routine lecturer and instructor for SEAVET at University of Florida, MARVET Grand Cayman and AQUAVET® III. She is also a guest lecturer at the University of Georgia. She has authored or coauthored numerous book chapters and peer reviewed publications focused on various areas of aquatic animal health.

#### Nominee for Treasurer: Dr. Alexa Delaune

Dr. Alexa Delaune obtained her DVM and certificates in aquatic animal medicine and international medicine from the University of Florida in 2010. Following veterinary school, she completed a one-year, small animal rotating internship in private practice. In 2011 she began working at the Georgia Aquarium as a veterinary intern. After completing her internship, she was kept on staff and completed a fellowship and was then hired as an associate veterinarian. In 2016 she was promoted to senior associate veterinarian, a position she held until October 2019. At Georgia Aquarium she was co-leader of the student externship program, taught classes and labs in the AQUAVET® III program, and became a co-leader for the AZA SAFE sharks and rays blood project. Dr. Delaune is currently the Vice President of Veterinary Services at Mississippi Aquarium where she is creating the veterinary program for the Mississippi Aquarium which is scheduled to open in 2020. She has been a member of IAAAM since 2006 and is excited by the possibility of joining the IAAAM executive board as treasurer.
