#### FORMAT INSTRUCTIONS FOR IAAAM ANNUAL PROCEEDINGS, 2003

Authors are encouraged to use the enclosed sample as an example of format and structure.

- 1. Submit one hard copy of the abstract/manuscript and one copy (Rich Text Format **ONLY**) on disk (IBM-compatible **ONLY**). Label the disk with your name, title of paper, and word processing program.
- 2. Use one inch (1") margins on both sides, top and bottom of each page. Text should be full justified (do not use left or right alignment). Do **not** number pages.
- 3. The entire title should appear in **BOLD UPPERCASE** letters at the top of the first page, using a Times or Times Roman font with a 14 point type size.
- 4. Names and current professional affiliations of all authors should be listed below the title at the top of the first page in **bold**. The name of the author presenting the paper should be identified with an asterisk (\*), and affiliation addresses should be italicized.
- 5. Start the abstract/manuscript with the heading **ABSTRACT** in bold uppercase letter, then skip a double space before starting abstract/manuscript text.
- 6. The text of the abstract/manuscript should be single-spaced, using a Times or Times Roman font (size 12) throughout the text. Scientific names should be given in *italics*.
- 7. Student abstracts must be 500 words or less to be considered for Student Travel or Presentation Awards.
- 8. Avoid heavy solids or graphics with dark backgrounds. Simple line drawings or graphics reproduce the best and are encouraged.
- 9. References, if included, should be cited in the abstract/manuscript text with superscript numbers and the **LITERATURE CITED** section should be arranged alphabetically at the end of the manuscript. All references contained in the reference list must be cited in the text. Citation style is provided in the enclosed example.
- 10. Students should send separate copies to the Program Chair (Nina Young) with student classification noted and to the Student Travel Awards Committee Chair (Dr. T. Romano) to apply for travel support. Student abstracts are submitted in one of four categories: Basic Research, Descriptive Investigation, Case Report or Poster.
- 11. Double-check for spelling errors and compare your format with the enclosed sample!
- 12. The abstracts should be informative and stand alone. Using "to be described or discussed" is not acceptable.

#### **ABSTRACT**

A five year old male bottlenose dolphin developed a harsh cough in August of 1995. The dolphin was born at Sea World of Texas in August of 1991 and was moved to Sea World of California in September of 1993. Prior to this, the dolphin's medical history was unremarkable.

On physical examination the dolphin appeared slightly underweight and had prolonged inspiration and expiration. Laboratory tests indicated inflammatory disease, and radiographs demonstrated a 4-5 cm focal alveolar pattern in the left caudal lung lobe surrounded by mild to moderate interstitial changes. Blowhole samples for cytology were unremarkable and cultures grew normal blowhole flora consisting of *Morganella morganii*, *Staphylococcus intermedius*, and *Vibrio alginolyticus*.

# **Call for Student Travel Award Applications**

The Student Liaison Committee has been appropriated the sum of \$2000.00 to award to students intending to deliver **oral** presentations at the annual IAAAM conference in May 2003. The intentions of the awards are to defray the cost of travel to the May 10-14, 2003 conference in Hawaii to promote student participation in the professional program, and to further the commitment of the IAAAM to its students. Moneys will be awarded on a competitive basis, with the goal of supporting as many students as possible. Undergraduate students, Masters and PhD students, veterinary students, postdocs, and veterinary interns/residents are eligible. The requirements for all applicants include the following:

- \* A cover letter that describes the future plans of the applicant with regard to aquatic animal medicine.
- \* A copy of the abstract of the paper to be presented. This abstract must not exceed 500 words in length. Only abstracts will be considered.
- \* Curriculum vitae and two (2) letters of recommendation, one of which must be from an active member of the IAAAM.
- \* An itemized budget that details the travel expenditures (i.e. airfare, lodging, meals, etc) and indicates the funds available from student stipends and personal resources.
- \* The student presenter must be a member (with dues paid up-to-date) of the IAAAM.

The Director of Education of the Board of Directors of the IAAAM and the Student Liaison Committee will review the applications. Applicants will be ranked according to judgement criteria that will include: the quality of the written abstract (500 words or less), the justification/significance of the work, the complexity of the work relative to the student's academic achievements, and the commitment of the student to aquatic animal medicine. The intent of the Student Liaison Committee and the Board of Directors is to fund as many students as possible, beginning with the highest ranked and continuing through the list of ranked applicants until the appropriated funds have been exhausted. No awards will exceed \$500.00. The rankings will be determined from the entire pool of applicants; separate awards for different academic classes of applicants (i.e. undergraduate, graduate, veterinary) will not be offered.

The deadline for applications is **January 15, 2003**, and recipients will be contacted by March 1, 2003. **Students submitting abstracts for the travel award competition must separately submit their presentation for acceptance into the conference proceedings.** The Secretary/Treasurer of the IAAAM will be notified and will send checks to the successful applicants. The Student Liaison Committee and the IAAAM Board of Directors welcome this opportunity to assist deserving students.

# 34th Annual IAAAM Conference Pre-Conference Wet Laboratories and Workshops

#### Immunology for Aquatic Animal Clinicians-

Rhonda Patterson May 9, 2003 9am to 5pm

This workshop is directed towards veterinarians that would like an introduction or a review of basic immunological principles. The emphasis will be on the interrelatedness of the various components and divisions within the immune system. Given the diversity of organisms represented by aquatic animals there will be a brief section on the comparative immunology of these various organisms. The information provided (including the terminology that will be defined) will be of practical use for clinical situations. Hard copies of the PowerPoint presentations will be provided (along with disk copies for those who are interested). The last part of the day will include informal discussion time with a few researchers (Aldridge, DeGuise, Middlebrooks, Romano, and Stott) and what their projects could mean to your work as clinicians. Lunch is included.

#### Sea Turtle Necropsy and Hematology Wet Laboratory

This wet laboratory is for clinicians interested in post-mortem and clinical hematology techniques for sea turtles. Clinicians will participate in a demonstration and get hands-on experience in performing a necropsy of green sea turtles. Topics to be covered include basic anatomy, proper sample collection for histopathology, and brief discussions on major diseases of wild sea turtles. Hematology section will cover recognition of different white cell types of sea turtles, methods to conduct standard hematology (total white and red cell counts, differentials), and pros and cons thereof.
