## We are breaking records in 2005!

Well everyone, this year's conference in Seward, Alaska is going to set a record for the organization in the number of abstract submissions. We will be having 24 poster presentations and 115 oral presentations including two panel discussions. This is about a 33% increase over our usual number of submissions. WOW! The agenda is in this newsletter, so you can see what the various sessions are going to be about, and due to time constraints we had to restore to using concurrent sessions to fit it all into the time limit of the four days scheduled for the conference. Now, I know that concurrent sessions is not what this organization is used to nor is it something that many of our members would like to have happen; however, I did limit the number and length of the concurrent sessions as best as I could. This was simply the only way to accommodate all of the excellent presentations that were submitted.

The organization has never put in place a set of criteria for determining what to do if the number of oral presentations submitted exceeds the amount of time available for oral presentations without concurrent sessions. This is just one of the issues associated with an organization going through rapid growth. What is important to understand is that the members of the Executive Board are trying their best to keep up with these various issues and respond to them as quickly as possible.

In the meantime, we are going to have an **INCREDIBLE** time in Seward due to the hard work of the members of our host institution's planning team: Pam Tuomi, Donna Talamantes, Shawn Johnson, and Tracey Goldstein!! Be sure to give them a big "thank you" when you see them in Alaska. I look forward to seeing all of our speakers and our attendees next month in Seward!

# **Nominations**Frances Gulland, Nominations Committee Chair

The nominations committee of the IAAAM nominates **Dr William Van Bonn** for president-elect of the IAAAM, and **Dr Tracy Romano** for education officer on the IAAAM board. Elections will be held at the business meeting in Seward. Nominations from the floor for both positions are welcomed.

#### William ("Bill") Van Bonn, DVM

Bill received his DVM from Michigan State University in 1986, has been an active member of IAAAM since 1991 and is finishing a term as Board Member for Education. He has served as liaison with the Chair of the Student Committee and coordinated the auction at the annual meeting for several years in a row [except when he was off traveling in some distant place]. He spent 14 years working for the US Navy Marine Mammal Program advancing to the position of Managing Veterinarian for Research and Advanced Clinical Technologies and has recently accepted the position of Senior Veterinarian at the Shedd Aquarium. His professional interests include preventive medicine strategies for aquatic systems, molecular vaccinology, and advanced diagnostic imaging.

#### Tracy Romano, PhD

Tracy graduated with a BS in Biology from Saint Michael's College, Winooksi, VT in 1986. She received her PhD in Anatomy from the University of Rochester, School of Medicine & Dentistry, in Rochester, NY. Tracy received a fellowship for her graduate studies through the American Society for Engineering Education which enabled her to study with Dr. Sam Ridgway in collaboration with the U.S. Navy's Marine Mammal Program during the summer months. Tracy combined what she was learning at the Navy with the knowledge gained at the University of Rochester about neural-immune system communication to begin a new field dedicated to understanding the marine mammal immune system and how stress and the environment effect marine mammal health. After receiving her PhD in 1993, Tracy was awarded a postdoctoral fellowship through the National Research Council to continue her work in this field at the Navy Laboratory in San Diego in collaboration with The Scripps Research Institute in La Jolla, CA. Following her postdoc, Tracy established a research laboratory at the Navy facility bringing the technology learned at Scripps and funding awarded through grants to study marine mammal neural-immune system communication and health. She has been a member of IAAAM since she was a graduate student in 1988. Soon after completion of her PhD in 1993, Tracy volunteered to be a member of the IAAAM Student Liaison Committee and for the past 5 years as been the Chair of this Committee. Since May 2004, Tracy assumed the position of Vice President of Research & Veterinary Services at the Mystic Aquarium & Institute for Exploration in which she is leading an exceptional research team dedicated to aquatic animal health research and medicine.

## **Issues to be Voted on at Annual Business Meeting**

At the business meeting during the annual conference, the full members will be asked to vote on the following two issues. If you are not able to attend the meeting this year, then you can send your vote, via email or postal mail, to Lisa Mazzaro, the secretary of the organization (lmazzaro@MysticAquarium.org). Your vote must be into Lisa by May 10, 2005.

#### **Issue 1: Production of archival CD**

The Executive Board has been looking into the production of a new archival CD using OmniPress (the former CDs were produced by another company that no longer performs this service). The CD would use Adobe Acrobat, so it would be useable on MACs, PCs, or Linux versions of Unix. All abstracts on the CD-ROM will be included in a full text search index. Files can be searched by any word or phrase. Results will display the appropriate titles and be ranked from highest to lowest by number of occurrences. The words or phrases will be highlighted in the corresponding files.

There are two options available to us.

#### **Option one:**

Option one would be to take orders and have just enough CDs produced to cover those orders, though the minimum number that can be ordered is 100 CDs. The cost per CD would be \$157.45 (US dollars). There would be no cost to the organization if this option was chosen.

#### **Option two:**

Option two would be to have enough made for the current membership and to provide them as a benefit of membership. The cost would be \$27.75 per CD. This option would mean that the organization would need to spend \$16,650 upfront to provide this benefit; however, within a couple of years the organization would recoup the money through dues payment. An additional advantage to option two is that OmniPress produces an archival CD that can be updated on a yearly basis for a minimum fee. This means that each year the CD that you would receive would have the entire set of archival information, plus the information from the current year's proceedings.

If you are sending in your vote, please indicate whether your vote is for either option one or option two.

#### Issue 2: Limited number of oral presentations or concurrent sessions

This year we have had more abstract submissions than ever before (over 130 submissions) and given that our time is limited we will be having concurrent sessions for the first time in IAAAM's history (except for the year we had a joint meeting with AAZV). IAAAM has always had a policy of accepting all submissions; however, if we are to keep the conference at the same length we traditionally have then it will be necessary to either limit the number of oral presentations (though not the poster presentations) or have concurrent sessions. If the vote is for limiting the number of oral presentations, then the Executive Board will determine and publish (via the newsletter and the website) the criteria by which the submissions will be judged for acceptance as an oral presentation. If the vote is for concurrent sessions, then the President-Elect (who is responsible each year for the scientific program) will arrange the minimum number of concurrent sessions necessary to accommodate the number of oral presentations requested while also arranging to have as divergent as possible the topics going on in the concurrent sessions.

If you are sending in your vote, please indicate whether your vote is for limited number of oral presentations or for concurrent sessions.

## Student Update Tracy Romano, Student Liason

The IAAAM Student Liaison Committee had a difficult time choosing this year's student travel award recipients. The following are this year's IAAAM travel award recipients and will receive monetary aid from IAAAM to attend the meeting this May in Seward, Alaska: 1). Robbyn Stoddard "The Effect of Rehabilitation of Wild Marine Mammals on Antimicrobial Resistance of Fecal Bacteria" 2). Ashley Linton "Assessment of Immune Function in Wild Bottlenose Dolphins (*Tursiops truncatus*) Live-Captured in the Indian River Lagoon, FL and Charleston Harbor, SC" 3). Mandy Keogh "Simultaneous Measurement of Phagocytosis and Respiratory Burst Activity of Polymorphonuclear and Mononuclear Leukocytes in Whole Blood from Bottlenose Dolphins (*Tursiops truncatus*) Utilizing Techniques in Flow Cytometry" 4). Woutrina Miller "Habitat Quality in California: Risk Factors for Detecting Fecal Pathogens in Coastal Ecosystems". Congratulations to this year's winners and all those that applied for the outstanding quality of clinical and basic research investigations. Thank you to the judges for their time and efforts with the student travel awards.

IAAAM will also give student presentation awards at the upcoming meeting as in past years. Award will be given to the best student presentations in the following categories: 1). Postdoc, Resident, Intern (and/or have DVM) 2). Undergraduate, veterinary, graduate student (Master's or PhD) 3). Posters. In addition, this year special awards will be given to the best overall student presentation on aquatic birds and to the best overall clinical case report. Students must be IAAAM members with dues paid up-to-date to be eligible for the awards.

There will be a student workshop at this year's meeting in Seward. Dr. Robert Kaeser will start off the workshop with a presentation and discussion on "Presentation Skills". He will share helpful hints with students for decreasing nervousness during presentations, understanding and enhancing individual style, engaging the audience, and fielding questions. Dr. Kaeser's presentation will be followed Ashley Linton, IAAAM student representative. Ashley will give an overview on educational and career opportunities for students at all levels including undergraduate, graduate, veterinary, postdoctoral and residency programs. Volunteer, internship, and special courses in aquatic animal medicine and health will also be presented. There will be plenty of time for discussion so students are encouraged to bring their questions, ideas, and thoughts to the workshop. IAAAM has donated funds for food and beverages for those students attending and participating in the workshop.

This year at the meeting a special student bulletin board will be posted for student correspondence, messages and announcements. We will need student volunteers for help with the student auction. Please join us in Alaska for what promises to be a meeting full of learning, exchange of ideas and information, friends and fun. Hope to see you there!

# Dr. Sam Ridgway Honorary Diplomate of the American College of Zoological Medicine

Dr. Sam Ridgway, honorary life member of IAAAM, is ACZM's newest honorary diplomate. Dr. Ridgway is one of the founding fathers of marine mammal medicine, having completed the lion's share of the seminal work in marine mammal medicine, while continuing to this day to promote both applied and basic research in the field of marine mammalogy. He has published over 250 papers, book chapters and books, including one of the most definitive works on marine mammals, Mammals of the Sea, published in 1972.

Dr. Ridgway completed his DVM at Texas A&M in 1959 and his PhD in 1962 from Cambridge University. He has spent his entire career working for the US Navy Marine Mammal Program and is currently the Senior Scientist for Animal Care and Research. Dr. Ridgway has served on 14 PhD committees and has personally trained over 25 veterinarians through two to six year tours of duty in the US Navy Marine Mammal Program. He was founding president of the International Association for Aquatic Animal Medicine, and has been a scientific advisor on the Marine Mammal Commission and the National Research Council, National Academy of Sciences. He is currently Adjunct Professor of Comparative Pathology at the Medical School, University of California, San Diego. Dr Ridgway served for over 5 years on the Board of Trustees of the Zoological Society of San Diego chairing their Animal Health Committee.

Dr. Ridgway and his wife Jeanette have resided in the beautiful seaside town of Point Loma, San Diego for the past 33 years. Jeanette possesses a doctorate in English literature and has taught at the UCLA, UCSD, and San Diego State Universities. Dr. Ridgway has recently gone into semi-retirement with the Navy Marine Mammal Program, simultaneously taking a leadership role in the cooperative veterinary medicine program between UCSD and UCD.

Dr. Ridgway was nominated by Tom Reidarson and Pat Morris, and received his certificate at the joint AAZV/AAWV/WDA meeting in San Diego, California in September 2004.
