Call for Student Travel Award Applications

The Student Liaison Committee has been appropriated the sum of \$2000.00 to award to students intending to deliver **oral** presentations at the annual IAAAM conference in May 2007. The awards are intended to defray the cost of travel to the May 5 - 9, 2007 conference in Orlando, Florida in order to promote student participation in the professional program, and to further the commitment of the IAAAM to its students. Moneys will be awarded on a competitive basis, with the goal of supporting as many students as possible. Undergraduate students, Masters and PhD students, veterinary students, veterinary interns/residents, and postdocs are eligible. The requirements for all applicants include the following:

- 1. A cover letter that describes the future plans of the applicant with regard to aquatic animal medicine.
- 2. A copy of the abstract of the paper to be presented. This abstract must not exceed 500 words in length. Only abstracts will be considered.
- 3. Curriculum vitae and two (2) letters of recommendation, one of which must be from an active member of the IAAAM.
- 4. An itemized budget that details the travel expenditures (i.e. airfare, lodging, meals, etc) and indicates the funds available from student stipends and personal resources.
- 5. The student presenter must be a member (with dues paid up-to-date) of the IAAAM.

The Education Member of the IAAAM Executive Board and the Student Liaison Committee will review the applications. Applicants will be ranked according to judgement criteria that will include: the quality of the written abstract (500 words or less), the justification/significance of the work, the complexity of the work relative to the student's academic achievements, and the commitment of the student to aquatic animal medicine. The intent of the Student Liaison Committee and the Executive Board is to fund as many students as possible, beginning with the highest ranked and continuing through the list of ranked applicants until the appropriated funds have been exhausted. No awards will exceed \$500.00. The rankings will be determined from the entire pool of applicants; separate awards for different academic classes of applicants (i.e. undergraduate, graduate, veterinary) will not be offered.

In response to requests from the IAAAM membership, the deadline for receipt of the original signed applications has been extended this year to February 15, 2007. Applications received after the deadline will not be considered. Recipients will be contacted by March 15, 2007. Students submitting abstracts for the travel award competition must still separately submit their presentation for acceptance into the conference proceedings. The Secretary/Treasurer of the IAAAM will be notified and will send checks to the successful applicants. The Student Liaison Committee and the IAAAM Executive Board welcome this opportunity to assist deserving students.

THE CONUNDRUM SESSION IS BACK!

To: Fellow IAAAM clinicians From: Michael Briggs, DVM, MS

Re: The return of the conundrum session (as seen historically at the IAAAM annual conference)

Many IAAAM members, including me, have enjoyed the Conundrum Sessions that have occurred from time to time during our annual meetings. I did a "non-scientific survey" asking whether we should have a conundrum session or not and got 100% response. Of the 100% response, I also received 100% "Yes we should have it!" (Okay, there were just four of us, but our percentage of response was much higher than Don's for the entire 2006 conference!) Somewhere in the middle of complaining too loudly about not having one; I have become the "session chair" of one. Don Stremme has found some time to allow us to have one in 2007 at the meeting in Orlando. It will probably be Monday evening, May 7th at 6 pm - location to be announced.

One of the stipulations for me to chair this session was to set parameters and rules on it and not just have an endless extension of more papers? Don agreed, so we are going to have a "Conundrum" session. When you look up Conundrum in a Thesaurus, one gets the words, puzzle, mystery, challenge, problem, and riddle. No where does it say, "Another resolved case," or "Damn, I'm right again!" It also doesn't say anything about being partially complete with a research project and "results will be given next year!"

What we are looking for are clinical cases that are baffling.... puzzling... caus'n you to scratch your head... Cases you are so bewildered about it you just can't imagine going another day without telling EVERYONE how totally confused you are! But seriously, we would like to receive a loose outline of the case with basically; signalment, history, clinical presentation, diagnostics, rule-outs, clinical course, treatments, some supporting work you may have done as in a literature search for the rule-outs, etc. We don't want this to become a treatise on some fascinating disease you have solved. That is for the regular sessions. Nor do we want the recipe on how an ELISA is done or another laboratory technique we could look up in a book. PowerPoint presentations are discouraged as they tend to distract from the "feel" of just discussing a case with friends and colleagues. Also, long video of animals swimming around the tank or gradually eating more and more are discouraged. It is basically coming down as semi organized "shop talk."

Please submit any ideas for this session to me by the time final papers are due. Since this is more casual than our formal presentations, there will be room for you if you have something crop up after that, but I want to get a feel for how many might be actually presenting things. Depending on interest and number of folks interested, I would like to have three or four more complete or complex conundrums and I am hoping to assemble a "Panel" to help with a variety of questions that crop up that clinicians deal with all the time. It is sometimes good to revisit issues that we all thought everyone knew about but are still asked by other veterinarians, trainers,

and water quality personnel. Things like the questions, "Should we do salt dips on sea lions with bad eyes?" "Why are the sea lions teeth black?" "Are salt tablets effective for pinniped that live in fresh water?" "How can you tell when a jelly fish has been humanely euthanized?" These questions may be put in a "Hit List" format, so please send me any thoughts or ideas on that and I will try and make something come of it. I also hope that if there is a paper given during regular sessions with a "hot topic" we might be able to discuss that, as often there is too little time during the sessions. If there is enough interest in other issues that are a point of debate or needs the flow of open ideas, we will do that as well.

Again, I hope we can make this a very interesting session. Fish, bears, dolphins, shore birds, seals and sea lions.... Everyone is welcome! If you like to think and help solve our tough problems or just want to get into a relaxing information trading mode, this is the session for you!

Second Annual Marine Mammal Pathology Workshop

The Second Annual Marine Mammal Pathology Workshop hosted by The C.L. Davis Foundation will be held in on Saturday May 5th from 8:00 until 4:30 pm. The workshop will be held in conjunction with the IAAAM meeting in Orlando, Florida. This workshop is designed to increase interactive discussion regarding the pathology of marine mammals. Pathologists, clinicians, and interested students are invited to attend.

This year's Keynote speaker will be Dr. Dave Rotstein from the University of Tennessee. Dr. Rotstein will present material regarding the pathology investigation of stranding and mass strandings of marine mammals.

This year's workshop will again be on the general theme of marine mammal pathology. Case submissions can include classical lesions, novel conditions, common diseases in uncommon species, and diagnostic conundrums.

The workshop attendance fee will be \$50 and will include a DVD of the slides and case materials.

Should IAAAM develop official position statements or should IAAAM establish a policy that it does not develop official position statements?

A mechanism for generating official policy statements by IAAAM was drafted and approved at the 2004 Annual Business Meeting in Galveston, Texas, as follows:

Policy/Position Development Process

- 1. Individual in consultation w/ member of the Governmental Affairs/Policy Committee (GAPC), submits proposed policy/position or other request to either Executive Board or Governmental Affairs/Policy Committee-- Positions taken by the Government Affairs/Policy Committee should be restricted to those that provide guidance on or that promote aquatic animal medicine and health.
- **2.** GAPC discusses, consults with experts from membership, provides feedback, and either approves/disapproves moving forward with position development.
- **3.** GAPC may assign "project to a team". Project team develops timeline and policy position.
- **4.** First draft submitted to GAPC, posts on website, and consults other reviewers, as necessary.
- **5.** Project team incorporates/resolves comments, submits second draft to GAPC and Executive Board--either minor changes, or return to project team for additional work
- **6.** Project team resolves any Executive Board concerns; Executive Board-approves document by simple majority. Document is posted on the website for two weeks to allow for comments by the membership.
- **7.** Project team incorporates/resolves any additional comments and produces final draft for formatting, printing, and signature.
- **8.** Copies are provided to appropriate targets, posted on the Website, GAPC and Secretary maintain copies.

This mechanism was applied in the development of a position statement in support of passage of the Farr Bill, H.R. 3545, The Southern Sea Otter Recovery and Research Act, and a letter to that effect was sent to Congressman Farr on July 15, 2004. Both the letter and the position development process were reprinted in the August 2004 IAAAM Newsletter. This is the only time the mechanism has resulted in a position statement by IAAAM. It was applied again in 2006 in response to a request for an official endorsement by IAAAM of the AAZV euthanasia document. At that time, objections were raised about whether or not developing and issuing policy statements was an appropriate activity for IAAAM, irrespective of the merits of the case. Due to time constraints with the request, this issue could not be resolved in a timely manner, and no official endorsement was issued. It was also noted that we do not have a standing Government Affairs/Policy Committee. This mechanism does not apply to IAAAM's representation on AVMA Committees (AVMA Animal Agriculture Liaison Committee, AVMA Committee on Environmental Issues, and AVMA Food Safety Advisory Committee), but IAAAM may be involved in developing policy positions by that representation. The question posed above, "Should IAAAM develop official position statements or should IAAAM establish a policy that it does not develop official position statements?" will be considered at the 2007 annual meeting. Please provide your feedback to members of the

executive board prior to the meeting.

American College of Zoological Medicine (ACZM) Ultra-short Course

The ACZM Education Committee will sponsor a 1-day ultra-short course in conjunction with the IAAAM Conference in Orlando. The ultra-short course is divided into two main sections. The first section is meant to introduce to the attendee to the ACZM, reasons for becoming a Diplomate of the ACZM, how to become eligible to take the ACZM examination, and provide study and test-taking strategy, including a short mock exam. Potential authors: Corresponding authors interested in having manuscripts published in JAVMA should provide the tentative manuscript title, all potential authors, and full contact information for each author.

Implementation Process

INTRODUCTION

Contemporary veterinary medicine clearly includes an increasing number of aquatic animal species from marine mammals, to commercial aquaculture, ornamental (pet) finfish, amphibians and invertebrates. Veterinarian involvement is wide, involves all veterinary disciplines and includes governmental activities and program diseases, private industry and academic research, therapeutics and biologics, private clinical and university teaching hospital practice, wild fisheries rehabilitation, seafood safety, public health and biosecurity.

Being uniquely positioned, the JAVMA is able to provide a cohesive source and exchange of centralized, moderated and peer-reviewed aquatic veterinary information to veterinarians actively engaged in this wide range of aquatic veterinary activities and species.

This document outlines the process and requirements for three focused areas of aquatic veterinary publications in JAVMA and focuses on education through publication of didactic exercises, clinical case reports, updates or reviews of clinically relevant topics to aquatic animal veterinarians, and emerging issues that directly affect the practice of aquatic animal medicine. It also outlines the process and requirements for expediting solicitation, review, and processing of manuscripts in order to assist JAVMA staff, authors, and JAVMA readers.

AREAS FOR PUBLICATION

Manuscripts will be accepted for processing, review, and possible publication under the following sections:

- Aquatic Animal Section
- Current features in Veterinary Medicine Today
- Emerging Issues in Aquatic Veterinary Medicine—New feature within Veterinary Medicine Today

Authors will submit manuscripts for possible publication through established JAVMA channels and prepared in accordance with published JAVMA guidelines. These manuscripts would be processed in accordance with existing JAVMA policy.

Aquatic Animal Section

Aquatic animal reports are full-length manuscripts of an Original Study, Retrospective Study, Clinical Report, or Descriptive Report, as currently published in JAVMA under species categories in accordance with established JAVMA instructions for authors and manuscript processing.

Veterinary Medicine Today Features

Manuscripts on aquatic animal medicine will also be considered for publication in the Veterinary Medicine Today section of the JAVMA in current features, such as "What is Your Diagnosis?", "Timely Topics in Nutrition," or "Topics in Drug Therapy." Manuscripts could include descriptive approaches to clinical aquatic cases illustrating contemporary aspects of aquatic clinical practice that are of immediate use to veterinarians desiring to expand their involvement in aquatic animal

medicine or use of existing or emerging diagnostic tests or procedures, surgical approaches or techniques, and the optimal use of drugs.

Emerging Issues in Aquatic Veterinary Medicine

Emerging Issues in Aquatic Animal Medicine would represent a new feature within the current Veterinary Medicine Today section of JAVMA.

Manuscripts considered for publication in this section would include brief, but complete and accurate, new or evolving issues of importance to the veterinary profession, but they may not be typically viewed as hard science or may be seen by clinical practitioners as immediately applicable to the practice of aquatic veterinary medicine (ie, more of a head's-up focus on emerging issues). Examples include legislative or regulatory issues, emerging environmental or ecological issues, and animal behavior or welfare.

INSTRUCTIONS FOR AUTHORS

Manuscripts for the Aquatic Animal Section or Veterinary Medicine Today Features

Manuscripts intended for the Aquatic Animal section in JAVMA or existing Veterinary Medicine Today features in the JAVMA (such as "What is Your Diagnosis?", "Timely Topics in Nutrition," or "Topics in Drug Therapy") must be submitted in accordance with current established JAVMA instructions for authors (see http://www.avma.org/journals/javma/javma_ifa.asp).

Instructions for Emerging Issues in Aquatic Animal Medicine (New Feature)

Emerging Issues in Aquatic Animal Medicine should have the following format:

- Preferably one, but no more than two, printed pages (manuscript submissions approximately 3 double-spaced typed pages; approx 750 to 1,000 words).
- References should be limited to 8 in number
- Authors should follow all general guidelines for manuscript preparation and submission, including guidelines for preparation of electronic copies of figures, provided in the online Instructions for JAVMA Authors.
- Manuscripts submitted need to contain the following sections:
 - **Title** Title must clearly indicate the topic and significance to clinical veterinary medicine.
 - **Author/s** If multiple authors, at least one of them should be a veterinarian, and affiliations of all authors (especially the corresponding author) must be noted.
 - Introduction A brief overview of the issue, how this relates to veterinary medicine, and a review of the pertinent information related to the issue.
 - **Body of the manuscript (identify relevant subheadings as necessary)** Describes the relevant issues in detail.
 - Discussion and Conclusions Relates the issues directly to the practice of, or impact on, aquatic veterinary medicine.
 - **References** All citations cited in the body of the manuscript.

PROCESS FOR SUBMITTING, MANAGING AND PUBLISHING CONTRIBUTIONS

Publication frequency will be a function of the number of suitable manuscripts submitted and reviewed through AVMA's standard processes. Before the new feature is started, at least 5 manuscripts must be received, processed through peer review, and tentatively accepted for publication.

- All manuscripts should be submitted to the JAVMA, preferably online
 (http://avma.manuscriptcentral.com) to expedite processing. However, manuscripts may also be submitted electronically to the JAVMA secretary (JAVMA@avma.org), who will assist with uploading of the manuscript and associated materials.
- Manuscripts submitted for consideration should identify the desired section or feature for inclusion (Original Study, Retrospective Study, Clinical Report, or Descriptive Report for the Aquatic Animal section; or the specific feature in the Veterinary Medicine Today section (such as Timely Topics in Nutrition, Topics in Drug Therapy, Emerging Issues in Aquatic Animal Medicine, etc).
- Manuscripts submitted for consideration will be routed to the appropriate AVMA Scientific Editor. A specific AVMA Scientific Editor will be designated to handle the new Emerging Issue in Aquatic Animal Medicine feature.
- The AVMA Scientific Editors will ensure manuscripts are reviewed in a timely manner. The AVMA Scientific Editor who handles the Emerging Issues in Aquatic Animal Medicine feature will work with a designated coordinator to ensure each manuscript is peer-reviewed by 2 or more reviewers. Review of each manuscript should be accomplished within a 3-week period.
- Based on reviewer's comments, the AVMA Scientific Editor will:
 - Reject the manuscript and inform the corresponding author, providing reviewer's key issues;
 - Request the corresponding author resubmit the manuscript with consideration of reviewer's comments; or,
 - Route the manuscript, with reviewer's comments to the appropriate JAVMA editorial staff for editing, formatting, and publication.

PROMOTION AND OTHER NECESSARY ACTIVITY

The following activities will need to be implemented:

- Solicitation and compiling of potential reviewers for each section.
 Subject matter expert reviewers will be sought from the membership of several of the small established or developing organizations with an aquatic veterinary focus (e.g. International Association for Aquatic Animal Medicine (IAAAM), Eastern Aquaculture Veterinary Association (EAVA), Association of Aquatic Veterinarians of British Columbia (AAVBC), Canadian Association of Aquaculture Veterinarians (CAAV), Association of Reptile and Amphibian Veterinarians (ARAV), American Association of Zoo Veterinarians (AAZV), Fish Veterinary Society (FVS), etc).
- 2. Solicitation of manuscripts for each section.

 Manuscripts will be solicited from members of the aforementioned organizations with an aquatic veterinary focus.
- 3. Designate coordinator who will work with the appropriate AVMA Scientific Editor to ensure efficient, effective peer review of manuscripts submitted for the Emerging Issues in Aquatic Animal Medicine feature.
- 4. Coinciding with publication of the initial installment of the new feature, Instructions for Authors for the Emerging Issues in Aquatic Animal Medicine feature will be added to the JAVMA Web page (http://www.avma.org/journals/javma/javma ifa.asp).
