### Dear IAAAM Members,

On behalf of the Disney family, we want to express our sincere pleasure at being your hosts for the 38th Annual IAAAM Conference, May 5th - 9th, 2007. We will host the event at Coronado Springs Resort in the middle of Walt Disney World Resorts in Orlando, Florida.

At Coronado, you will be centralized to all the Disney Theme Parks as well as SeaWorld of Orlando. The cost of a hotel room at Coronado Springs will be \$155.00 + tax per night (single/double occupancy) with a \$15 per person per night charge for each additional adult (up to four people in a room).



**REGISTRATION/HOTEL:** This year we will be trying something new to ease some of the pain of registration. The registration will be web-based and include the IAAAM registration as well as the added option of reserving a room at the Coronado Springs Resort. We request that you **REGISTER EARLY!** Disney Resorts are **VERY** popular, and you need to register early to ensure you can stay on site at the conference resort. If you prefer to stay at another hotel, reservations at other Disney resorts can be found at www.disneyworld.com. At the time of this letter, prices for various hotel rooms start at \$82 to \$279 per night depending on the resort. Note: There is no bussing between hotels or resorts! If you don't stay at the conference hotel, you will need a car. There is free parking at the Coronado Springs Resort. If you prefer not to stay at a Disney resort, please go to your favorite travel planning website, which will give you a plethora of choices to serve all tastes.

**TRANSPORTATION:** As an additional amenity for those flying into Orlando Regional Airport and staying at any of the Disney Resorts, there is the opportunity to catch the complimentary "Magical Express" from the airport to your hotel. The Magical Express will pick you up at Orlando International Airport, retrieve your checked luggage, and take you to your resort. **WORKSHOPS:** Workshops are planned for Saturday, May 5. Topics include Marine Pathology, Manatee Necropsies, and an Ultra-Short Course for the American College of Zoological Medicine.

Marine Pathology Workshop 8:00 AM - 4:30 PM

Marine Pathology Workshop 2006 will focus on diseases of marine mammals. The Keynote Speaker will be Dr. Davis Rotstein of the University of Tennessee. The workshop will consist of a keynote presentation and multiple case presentations for audience discussion and review. Cases will all have pathology findings and related discussion topics. Come for a day of investigation, discussion, and learning! Max number of participants: 50. **The Aquatic Pathology workshop will require a separate registration fee to be paid by check. Instructions for payment will be included in your confirmation letter.** 

ACZM Ultra-Short Course 8:00 AM - 5:00 PM

The ACZM ultra-short course is designed to answer questions about the American College of Zoological Medicine specialty board examination process. It also provides an opportunity for those considering the examination to learn about successful strategies and suggestions for navigating the examination process. The ultra short course will include major review presentations by four ACZM diplomates on material that examinees may encounter during the examination. The emphasis will be on day 1 (general knowledge) level material but may be from any of the five specialty areas: aquatic, avian, general zoo, herps, or wildlife. One mock quiz will also be included in the day long workshop. Max number of participants unlimited.

Manatee Necropsy Techniques 1:00 PM - 5:00 PM

The purpose of this lab is to introduce participants to Florida manatee necropsy techniques. Topics discussed will include anatomy, physiology, and relevant diseases. Participants will be actively involved in necropsy. Scrubs or coveralls are a must. The rest of the equipment will be available at lab (boots or plastic cover booties, knives, etc). Max number of participants: 12.

**ORGANIZED ACTIVITIES:** An Ice Breaker reception is planned to take place at Disney's Animal Kingdom where a chance to tour behind the scenes at Disney's Animal Programs will also be available. The "Zoo Day" will take place at SeaWorld of Orlando followed by a dinner at The Seas at Epcot.

# **Call for Student Travel Award Applications**

The Student Liaison Committee has been appropriated the sum of \$2000.00 to award to students intending to deliver **oral** presentations at the annual IAAAM conference in May 2007. The awards are intended to defray the cost of travel to the May 5 - 9, 2007 conference in Orlando, Florida in order to promote student participation in the professional program, and to further the commitment of the IAAAM to its students. Moneys will be awarded on a competitive basis, with the goal of supporting as many students as possible. Undergraduate students, Masters and PhD students, veterinary students, veterinary interns/residents, and postdocs are eligible. The requirements for all applicants include the following:

- 1. A cover letter that describes the future plans of the applicant with regard to aquatic animal medicine.
- 2. A copy of the abstract of the paper to be presented. This abstract must not exceed 500 words in length. Only abstracts will be considered.
- 3. Curriculum vitae and two (2) letters of recommendation, one of which must be from an active member of the IAAAM.
- 4. An itemized budget that details the travel expenditures (i.e. airfare, lodging, meals, etc) and indicates the funds available from student stipends and personal resources.
- 5. The student presenter must be a member (with dues paid up-to-date) of the IAAAM.

The Education Member of the IAAAM Executive Board and the Student Liaison Committee will review the applications. Applicants will be ranked according to judgement criteria that will include: the quality of the written abstract (500 words or less), the justification/significance of the work, the complexity of the work relative to the student's academic achievements, and the commitment of the student to aquatic animal medicine. The intent of the Student Liaison Committee and the Executive Board is to fund as many students as possible, beginning with the highest ranked and continuing through the list of ranked applicants until the appropriated funds have been exhausted. No awards will exceed \$500.00. The rankings will be determined from the entire pool of applicants; separate awards for different academic classes of applicants (i.e. undergraduate, graduate, veterinary) will not be offered.

\*\*In response to requests from the IAAAM membership, the deadline for receipt of the original signed applications has been extended this year to <a href="February 15">February 15</a>, 2007.\*\* Applications received after the deadline will not be considered. Recipients will be contacted by <a href="March 15">March 15</a>, 2007. Students submitting abstracts for the travel award competition must still separately submit their presentation for acceptance into the conference proceedings. The Secretary/Treasurer of the IAAAM will be notified and will send checks to the successful applicants. The Student Liaison Committee and the IAAAM Executive Board welcome this opportunity to assist deserving students.

## **Guidelines for the Euthanasia of Nondomestic Animals**

The Guidelines is an official publication of the American Association of Zoo Veterinarians, and has been endorsed by the American Association of Wildlife Veterinarians, the American Board of Veterinary Toxicology, the American College of Zoological Medicine, the Association of Avian Veterinarians, the Association of Reptilian and Amphibian Veterinarians, the Canadian Association of Zoo and Wildlife Veterinarians, and the Wildlife Disease Association.

Twenty eight authors and fifty seven reviewers contributed to the production of this 111 page document, including several IAAAM members.

In addition to sections covering the Aspects of Euthanasia and a Summary of Euthanasia Methods, there are taxon-specific recommendations for: <u>invertebrates</u>, <u>fish</u>, <u>amphibians</u>, <u>reptiles</u>, birds, monotremes, marsupials, bats, nonhuman primates, rodents and small mammals, <u>marine mammals</u>, <u>sea otters</u>, carnivores, hoofstock, swine and megavertebrates.

### **Positions Available:**

Aquatic Animal Veterinary Fellowship. The Animal Health Department at the New England Aquarium (NEA), Boston, Massachusetts seeks applicants for a two-year Aquatic Animal Veterinary Fellowship beginning 7/1/07. The aim of this program is to afford veterinarians the opportunity to develop skills in veterinary management at a public aquarium while participating in collaborative clinically-based research investigations pertaining to the health of captive and wild aquatic animals. The successful candidate will join a team of veterinarians, biologists, husbandry personnel, and environmental quality specialists. The Fellow will also participate in ongoing collaborative work with veterinary pathologists, pharmacologists, medical researchers, and other specialists. Evidence of recent research, scholarly productivity, and experience in aquatic animal, zoo, exotic and/or laboratory animal medicine are preferred. The candidate must have a demonstrated ability to work in a team atmosphere. An advanced, research-based, graduate degree and SCUBA certification are desirable. Candidates must possess a VMD/DVM degree, and be eligible for a Massachusetts veterinary license. New graduates will be considered. A competitive salary with generous benefits package will be offered.

This position is based in Boston, MA, but may require travel throughout New England for specialized training and/or marine animal stranding response. As directed by the senior veterinarians, the Fellow shares clinical responsibility for the New England Aquarium's (NEAq) medical caseload consisting of marine mammals, fishes, birds, reptiles, amphibians, and invertebrates [>15,000 animals]. Clinical proficiency in diagnostic testing procedures is required (e.g. biopsy collection, blood collection, radiography, ultrasound, and endoscopy). The Fellow's responsibilities also include: maintaining medical records in keeping with state and USDA regulations; conducting weekly medical rounds with other veterinary staff or independently; participating in NEAg's programs of animal quarantine and preventative health; teaching veterinary students; acting as the liaison between NEAq's medical/husbandry staff and consulting veterinarians; and working in the Aquarium Medical Center exhibit. The Fellow is responsible for conducting, compiling, and publishing the results of a clinical research project in a peerreviewed journal (manuscript submission must be within one month after Fellowship completion), and for submitting case reports to peer-reviewed journals as directed by the Head Veterinarian. The research project will be selected by the Fellow and approved by senior veterinary staff with priority given for studies of recurrent health problems in our animal collection, research and/or rehabilitation animals. Applicants should submit a statement of career goals and interests, *curriculum vitae*, 3 letters of professional reference, and a veterinary college transcript to: HR Dept. NEAq • Central Wharf • Boston, MA 02110. The deadline for applications is 3/15/07.

# "Health and Colony Management of Laboratory Fish" at Mount Desert Island Biological Laboratory

This course is a 1-week educational opportunity for individuals with maintenance, management or research responsibilities in which fish are used as laboratory animals. The course is offered at the Mount Desert Island Biological Laboratory, Salisbury Cove, Maine during the period of 17 - 22 September 2007. Topics to be discussed will include general system design and water quality management, anatomy and histology of fish, general fish diseases and disease management strategies. Infectious and non-infectious diseases common to all fish as well as specific diseases of importance to laboratory-maintained zebrafish will be discussed. The course will consist of lecture, laboratory exercises and discussions. During the course there will be an opportunity for students to discuss unusual and/or unsolved diagnostic case experiences from their home laboratories as problem-solving exercises.
