MESSAGE FROM OUR CONFERENCE HOST

Dear IAAAM Members,

The April 5th IAAAM Conference registration deadline is fast approaching. The current IAAAM Coronado hotel website will only be available until April 10th. After that you must book any Disney Resort by calling (407) 939-1020. The hotel is completely full on a few dates. At the time of this writing The Caribbean Beach Resort is being used as overflow for attendees needing housing May 5th. There have been several instances of people receiving a message when they try to register saying "no rooms available". If you get this message please either contact the registration staff by pressing the "Email Registration Assistance" at the bottom of the page or phone 407-939-1020 and they will be happy to accommodate you. Please do this as soon as possible since the rooms tend to go quickly. To register for both the conference and a room at the Coronado Springs Resort at the special conference rate, go to www.disneyurl.com/IAAAM (an optional Coronado Springs Resort registration hyperlink will be imbedded in the conference registration confirmation after you register for the conference). To register for Coronado Springs Resort rooms only, go to

www.disneyurl.com/InternationalAssociationforAquaticAnimalMedicine or call (407) 939-1020. At Coronado, you will be centralized to all the Disney Theme Parks as well as SeaWorld of Orlando. The cost of a hotel room at Coronado Springs will be \$155.00 + tax per night (single/double occupancy) with a \$15 per person per night charge for each additional adult (up to four people in a room).

If you prefer to stay at another hotel, reservations at other Disney resorts can be found at www.disneyworld.com. At the time of this letter, prices for various hotel rooms start at \$82 to \$279 per night depending on the resort. Note: **There is no bussing between hotels or resorts!** If you don't stay at the conference hotel, you will need a car. If you prefer not to stay at a Disney resort, please go to your favorite travel planning website, which will give you a plethora of choices to serve all tastes. For those traveling to the Coronado daily parking is free.

TRANSPORTATION: As an additional amenity for those flying into Orlando Regional Airport and staying at any of the Disney Resorts, there is the opportunity to catch the complimentary "Magical Express" from the airport to your hotel. The Magical Express will pick you up at Orlando International Airport, retrieve your checked luggage, and take you to your resort. Your luggage will go straight from the airport to your resort room, leaving no need to hassle with your luggage at baggage claim. When the meeting is over, they will do it all in reverse order. Disney's Magical Express Service is exclusively available when you stay at a Disney Resort hotel. WORKSHOPS: Workshops are planned for Saturday, May 5. Topics include Marine Pathology, Manatee Necropsies, and an Ultra Short Course for the American College of Zoological Medicine.

Marine Pathology Workshop 8:00 AM - 4:30 PM

Marine Pathology Workshop 2006 will focus on diseases of marine mammals. The Keynote Speaker will be Dr. Davis Rotstein of the University of Tennessee. The workshop will consist of a keynote presentation and multiple case presentations for audience discussion and review. Cases will all have pathology findings and related discussion topics. Come for a day of investigation,

discussion, and learning! Max number of participants: 50. The Aquatic Pathology workshop will require a separate registration fee to be paid by check. Instructions for payment will be included in your confirmation letter.

ACZM Ultra-Short Course 8:00 AM - 5:00 PM

The ACZM ultra-short course is designed to answer questions about the American College of Zoological Medicine specialty board examination process. It also provides an opportunity for those considering the examination to learn about successful strategies and suggestions for navigating the examination process. The ultra short course will include major review presentations by four ACZM Diplomates on material that examinees may encounter during the examination. The emphasis will be on day 1 (general knowledge) level material but may be from any of the five specialty areas: aquatic, avian, general zoo, herps, or wildlife. One mock quiz will also be included in the day long workshop. Max number of participants unlimited.

Manatee Necropsy Techniques 1:00 PM - 5:00 PM

The purpose of this lab is to introduce participants to Florida manatee necropsy techniques. Topics discussed will include anatomy, physiology, and relevant diseases. Participants will be actively involved in necropsy. Scrubs or coveralls are a must. The rest of the equipment will be available at lab (boots or plastic cover booties, knives, etc). Max number of participants: 12.

ORGANIZED ACTIVITIES: A tentative schedule has been provided and can be viewed on the IAAAM website. An Ice Breaker reception is planned to take place at Disney's Animal Kingdom where a chance to tour behind the scenes at Disney's Animal Programs Vet Clinic and Research Center will also be available. <u>Times may change slightly</u> but this should take place around 7 PM. The "Zoo Day" will take place the afternoon Tuesday, May 8th at SeaWorld of Orlando which will include lunch. After a brief refresher at the hotel, a dinner at Epcot's, The Seas will include a buffet dinner as well as behind the scenes walk-through tour, silent and live auctions and other surprises.

Biographies of the nominees follow.

Nomination for President Elect: Dr. Tom Reidarson

Dr. Tom Reidarson is currently Director of Veterinary Services at SeaWorld of California. Tom received his DVM from the University of California, Davis in 1985, completed an internship at the University of Minnesota, and then practiced in southern California focusing on small animals and marine mammals at a local stranding center. He joined SeaWorld in 1991, joined the IAAAM in 1992, and then became board certified in the American College of Zoological Medicine in 1999. Dr. Reidarson has published over 60 articles, abstracts, and book chapters on various aspects of marine mammal medicine and has lectured on the subject at many US, European, and Asian universities and zoological parks. Tom served a term as IAAAM board member for membership, served on the IAAAM excellence awards committee, and was the aquatics chairperson for the ACZM examination committee.

Nomination for Secretary: Dr. Lisa Mazzaro

Dr. Lisa Mazzaro, Assistant Director of Research and Animal Care at Mystic Aquarium, received her BS and MS degrees in Marine Biology from the University of North Carolina, Wilmington and her PhD in Nutrition University of Connecticut in conjunction with Mystic Aquarium. Lisa has been at Mystic for 15 years and has much experience with pinniped and penguin husbandry as well as seal rescue and rehabilitation. Lisa has an Assistant Professor in Residence Appointment in the Department of Animal Science at the University of Connecticut and she serves as the nutrition adviser for the Marine Mammal Taxon Advisory Group. Some of her research accomplishments include nutritional studies on Steller sea lions, the study of iron storage disease in fur seals, vitamin A and E metabolism in pinnipeds, and the lack of a need to supplement salt in the diet of penguins housed in fresh water. Lisa has been a member of IAAAM since 1993, has served on the student liaison committee since 2002 and served as IAAAM Secretary for the past three years.

Nomination for Board Member: Dr. Craig Harms

Dr. Craig Harms is Assistant Professor of Aquatic, Wildlife and Zoo Animal Medicine at North Carolina State University, College of Veterinary Medicine, Center for Marine Sciences and Technology. He received his DVM from Iowa State University in 1989, worked in small animal practice in Alaska for two years, completed an Internship in Exotic, Zoo and Wildlife Medicine at Kansas State University, a residency in Zoological Medicine—Aquatics Emphasis at NCSU, and in 1999 earned his PhD in fish immunology from NCSU. He is board certified by the American College of Zoological Medicine, and currently serves as ACZM Secretary. His clinical and research interests span aquatic invertebrates, fish, sea turtles and marine mammals, making IAAAM his single most useful meeting to attend each year. Craig has been a member of IAAAM since 1999 and has served as Board Member and Newsletter Editor for the past three years.

2007 IAAAM STUDENT TRAVEL AWARD WINNERS

Emotional Intelligence: When a high "IQ" is not enough

Being an effective contributor in modern organizations is complicated and challenging. - the MMHSRP Information Management Program.

Report from the Animal Agriculture Liaison Committee of the AVMA Mike Kinsel, for Roy Yanong

At the 15-16 February 2007 meeting of the Animal Agriculture Liaison Committee (AALC) of the AVMA, some aquatic animal/medicine issues that were discussed included the following:

- AVMA Legislative Agenda for the 110th Congress advocates support of The National Offshore Aquaculture Act and the Southern Sea Otter Recovery and Research Act, and non-support for the Natural Stock Conservation Act.
- Currently there is no funding in the 2007 budget for FARAD and Minor Use Animal Drugs programs. Whether or not this situation will change in 2008 budget cycle is uncertain. These programs may be of concern to some of the membership.
- The USDA and various state agencies are monitoring the Viral Hemorrhagic Septicemia outbreak in the Great Lakes. The virus is type IVb, most similar to isolates previously identified in the Canadian Maritime Provinces.
 - An emergency rule prohibiting movement of susceptible species was enacted in October 2006 and amended in November 2006. A final rule is expected soon.

- The order affects the states of Illinois, Indiana, Michigan, Minnesota, New York, Ohio, Pennsylvania, Wisconsin and the Provinces of Quebec and Ontario.
- Currently interstate movement from above states is restricted to animals for slaughter and human consumption, research or diagnostics, and shipments of animals with known/proven negative disease status, which has eased economic pressure on the aquaculture industry somewhat.
- The known host range for VHS is expanding. Channel catfish are now known as susceptible to infection, though whether active disease occurs is not fully understood.
- The temperature range for viral survival has also expanded; some information indicates survival up to 40C. Given higher temperature tolerance and ability to infect channel catfish, there is some concern in southern states with catfish production units for spread of VHS and the potential for severe economic impact.
- Economic losses have occurred in the Great Lakes states, particularly in baitfish production. Since the emergency orders restrict movement but do not mandate depopulation, there is no government reimbursement for losses.
- The USDA National Aquaculture Program website
 (http://www.aphis.usda.gov/vs/aqua) maintains updated information on VHS and includes the existing emergency order and a list of susceptible species.

Aquatic Veterinarian Group Formed

A new veterinary organization, the Aquatic Veterinary Association, will hold its first Annual General Meeting in conjunction with the American Veterinary Medical Association convention in Washington, DC in July 2007. The organization's mission is "to serve the discipline of aquatic veterinary medicine in enhancing and advancing the science and art of aquatic veterinary medicine, aquatic animal health and welfare, public health, and seafood safety in support of the veterinary profession, aquatic animal industries and other stakeholders." Interim Directors are Peter Merrill (President), Christopher Walster (Secretary), Susan Palic (Treasurer), Julius Tepper (Executive Director), Colin Johnston (Director-at-Large) and Timothy Miller-Morgan (Director-at-Large). THE 2007 MARINE MAMMAL MEDICINE AND PATHOLOGY INTERNSHIP THE MARINE MAMMAL CENTER SAUSALITO, CALIFORNIA

The Marine Mammal Center in collaboration with the University of California (Davis) has an exciting opportunity for a Veterinary Intern to work in our Veterinary Science Department. This is a one-year internship which is scheduled to start in mid-summer 2007, ending in mid-summer 2008. This position requires a DVM degree or equivalent. Previous marine mammal or wildlife experience is preferred. Preference will also be given to individuals who possess at least one year of clinical veterinary experience.

The Marine Mammal Center veterinary staff includes two full-time veterinarians, four veterinary technicians, and a medical laboratory technician. The Veterinary Intern's responsibilities include assisting the veterinary staff in providing medical management of a large number of marine mammals; mostly pinnipeds who are at The Marine Mammal Center for rehabilitation after having been stranded on the California coast due to injury, disease or malnutrition. The Intern will also be responsible for post mortem examinations, collecting samples for various research projects, and record-keeping. A research paper or case report should be completed during the internship.
