# ACZM Short Course [May 7th, 9:00AM to 5:00PM]

The American College of Zoological Medicine's Education Committee is proud to sponsor a 1-day ultra-short course in conjunction with the International Association for Aquatic Animal Veterinarians 2010 Conference. The annual conference will take place in Las Vegas, NV from May 7th – 11th, 2011. The ACZM Ultra-short Course will be held on Saturday, May 7th from 9:00AM to 5:00PM. Important topics in aquatic animal medicine will be presented in a series of mini-lectures, and the ACZM boards preparation process will be discussed, with practice exam sections. # Marine Mammal Intraoral Radiology Workshop [May 7th, 12:00PM to 4:00PM]

This workshop will be 25% lecture and 75% hands on. It is an opportunity to learn efficient positioning techniques to get consistent diagnostic images in a variety of marine mammals. The lecture will discuss equipment necessary to take intraoral radiographs in marine mammals, radiographic positioning and diagnosis of intraoral disease. The hands-on portion will be positioning skulls and taking radiographs using dental radiographic units with digital sensor and or CR digital plates and software. Wet lab will be geared to meet the needs of the participants with multiple stations. Participants will also learn more about using the various software enhancements, image orientation and film processing troubleshooting as well as interpretation of findings and how that translates to treatment options for common dental and oral pathology. *Workshop Registration \$75* 

#### Latin American Marine Mammal Veterinary Workshop [May 7th, 9:00AM to 5:00PM]

This workshop will be 100% lectures in Spanish focusing on topics that Latin American Veterinarians (clinicians and researchers) are currently working on or are developing in the area of aquatic animal medicine in their countries. By planning this special session in Spanish, Latin American students and veterinarians will get the opportunity to share the focus areas of their jobs and research and encourage collaborations amongst them. The Medway Endowment is working hard to fund students. As the endowment grows, the IAAAM can do more and more to support student endeavors.







# TREASURER'S REPORT

This is the first year that we have completed the lion's share of our financial transactions (including the 2010 Conference registration and payments) using the on line credit card portal. This has shifted the recording of conference income from the host institution to the IAAAM bank account with a corresponding disbursement of those funds to the host to defray their conference expenses.

I have continued to use the power point template to report the '08-'09 and the '09-'10 income and expenses to help to clarify the various financial categories of the Association. I have included a column to show the income, expenditures and bank balances for the first 4 months of the current fiscal year as well as the proposed budget for FY 2010-2011.

**INCOME** (\$133,318.33) includes 2010 Conference registration income and donations to IAAAM that were not originally included in the planned budget.

Medway Endowment Investment Net Income (\$2941.96)

Money Markey Interest income (\$231.70) was a less last year than predicted, primarily due to the poor interest rates available. In addition, our balance in this account has decreased by the transfer in July 2009 of \$50,000 that was being held to initiate the Medway Endowment investment account with Curian Clearing. The interest income projection for the IAAAM bank account for 2010-2011 was adjusted accordingly.

The Student Auction – (\$4430.80) used to cover Student Award and Committee expenses annually with any excess to be deposited into the Medway Endowment investment account.

Conference Proceedings (\$70.00) income only reflects copies sold after the end of the 2010 annual meeting. The 2010 host retained \$1679.51 from sales of proceedings during the conference to help defray other meeting expenses.

2009 Meeting Pass Thru - IAAAM received a check in August 2009 for reimbursement of \$3,495.95 from Sea World as a return of unspent 2009 meeting pass-through income.

2010 Meeting / WetLab Pass Thru (\$72,610.56) shows all of the 2010 Annual Conference income generated through the IAAAM credit card web portal and monies received by the Treasurer including some of the sponsorship money and wet

lab income. These payments were deposited directly into the Association checking account. Since American Express deducts a small percentage of the amount charged at each transaction, the total deposited is not in round numbers and is a little less than the total of the registration fees collected from the members. Money received directly by Vancouver Aquarium and used to defray meeting expenses does not appear in this column.

Donations (\$32,127.76) include funds received during this fiscal year specifically for deposit into the Medway Endowment Fund as well as undesignated donations received.(NOTE: \$6412.76 "profit" from the 2009 Conference was received from Sea World in addition to the Meeting Pass Thru income shown above and this accounts for the majority of the undesignated donation.)

*Membership income* (\$15,530 for 2009-2010 plus \$50 for '08-'09 dues and \$1,830.00 collected for 2010-2011 dues) was similar to date to previous years. On-line renewal is continuing steadily although we still have a number of members whose payments have been listed as "incomplete", "pending" or "bad card" and a few where the member's credit card was charged twice. Dr. Driscoll and I are communicating with these members to resolve their payment issues and manually generating receipts as needed.

**EXPENSES** (\$92,446.14) include Pass Thru payments to the Vancouver Aquarium of money collected for the annual meeting but not previously budgeted.

Executive Board Expenses (\$1064.95) include monies spent by the President, President Elect, Secretary and Treasurer for postage and office supplies, for gifts to our conference host and outgoing board members, and for other expenses incurred over the past two years on behalf of the Association.

2010 Meeting Pass Through (\$71,294.24) All of this 2010 Meeting Income was transferred to the Vancouver Aquarium Meeting Committee's conference account for their use in paying the meeting expenses. The detail of 2010 Meeting Pass Thru Income is shown on Part 2 of this report.

*Midyear Executive Board Meeting* business has been conducted primarily by email so no expenses were incurred for that category.

*Communications/ Publications* (\$4,195.00) are fees paid to Affiniscape to maintain our website including the credit card portal plus supplies needed by our webmaster.

Awards Committee (\$115.43) expenditures were used to purchase plaques presented during the meeting to the Mark Keys and Honorary Life Member Award recipients.

Legal and Professional Expenses (\$2,365.00) covered the cost of accounting and tax return preparation plus the premium for our Directors' and Officers' Liability Insurance. This cost will increase next year as we are being asked to provide meeting Liability insurance by the 2011 Conference hotel and the board also plans to purchase meeting cancellation insurance.

Bank / Credit Card Fees (\$3,541.52) are charged by our bank (Capital One) and credit card managers (Cynergy Data and American Express) and include monthly service charges, check printing, and fees on each credit card transaction. Because we have migrated to credit card payments on line for the majority of our income, this expense category has increased significantly over our '07-'08 costs but is hopefully offset by making it easier for members to pay and by decreasing the need to mail and handle checks, chase lost payments and deal with exchange rates for our international members. Proceedings/CD (\$6,570.00) includes the cost of the archival CD discs provided at the Conference plus the costs for supplying a small number of printed proceedings. This category also includes fees for on line abstract submission, production costs and for shipping and mailing of proceedings. An invoice for mailing of remaining CDs to members not present at the 2010 meeting was paid in July 2010 and is reported in that column.

*Student Liaison Committee* conducted business by email this year and did not incur any expenses as the student workshop costs were donated by the Vancouver meeting sponsors.

Student Awards (\$3,300) were again offered to outstanding student members to support expenses that they incurred to attend and present at the 2009 meeting. Five students each received a \$500 TRAVeL Award and five Presentation Paper Prizes (total of \$800.00) were given this year.

#### 2010 - 2011 Year to Date

The section showing actual income and expenses for July through October of the current fiscal year includes expenses of \$3,000 paid to the Las Vegas Mirage as a deposit for the 2011 meeting and travel expenses for our vice president to meet with the 2011 conference organizers in Las Vegas earlier this fall.

#### Additional information:

At the end of the budget chart, I have included a section showing DONATIONS, broken down by category and fiscal year to highlight this category separately from the rest of the IAAAM financial activity. Member donations for the Medway Endowment reached our goal of \$55,000 in June 2009 and that figure was matched by checks from Dr. Jay Hyman for \$50,000 and from Dr. Jay Sweeny for \$5,000. Although they were initially deposited in the association's checking and Money Market accounts, Dr. Tepper transferred the total \$110,000 collected for the Endowment to an investment fund at Curian Clearing in July 2009. He will continue to work with the Judy St. Leger and others on the Student Awards Committee to monitor and manage the Endowment.

Liquid ASSETS of the Association are distributed between our Money Market, Business Checking and Curian (Medway Endowment) Investment accounts. Overall, the Association continues to have a stable cash flow and is expected to meet all of our financial obligations in FY10-11 with a comfortable net worth given our usual expenditures. Sufficient cash reserves may also be held to self-insure for any meeting expenses that would be incurred if a meeting had to be cancelled after contractual agreements with hotels and other vendors had been signed.

# **DUES RENEWAL NOTICE**

#### Dear IAAAM Member:

Your IAAAM dues are due by July 1st of each year. Your membership fee entitles you to the newsletters available on the members-only area of the web site. Other benefits include a membership directory, a searchable online archive of the annual conference proceedings, and a reduced conference registration fee.

Current memberships fees are as follows:

Full Membership \$50 Student Membership \$30 Institutional Membership \$70

While it's true we don't charge a late fee, there is a cut off date of March 1st, 2011. If you haven't paid by then, you will no longer be a member. In that case, you will have to reinitiate your membership as a new member with a résumé and signature from a current member. This cutoff date helps us produce the membership directory. This also helps the conference host, since they will have a finalized list of members who receive the reduced conference rate.

# CHANGES TO THE ACZM BOARD EXAMINATION

The ACZM was established in 1983 as an international veterinary specialty organization recognized by the American Veterinary Medical Association for certification of veterinarians in zoological medicine. The ACZM is responsible for establishing training requirements, evaluating and accrediting training programs, and examining and certifying veterinarians in the veterinary specialty of zoological medicine. Currently, there are over 130 ACZM diplomates serving as zoo and wildlife veterinarians, college and university faculty members, private practitioners, government officials and administrators fostering high quality veterinary care for non-domestic animals, and discovering and disseminating new knowledge in the field.

The ACZM certification examination currently consists of a Day 1 qualifying examination, which includes the medicine of avian, aquatic, reptilian and amphibian, mammalian, and free-ranging wildlife species. Candidates who pass Day 1 proceed to take the Day 2 certifying examination in one of five focus areas: General Zoo (birds, reptiles, and mammals), Wildlife, Aquatic, Avian, or Herpetological Medicine. In 2011 a new Day 2 certifying examination will be offered in Zoological Companion Animal Medicine, with content as outlined in the chart below. This will also be the last year a candidate can select the Day 2 certifying examination in Avian or Herpetological Medicine as a first time applicant. Candidates selecting these options in 2011 or before will have through 2013 to pass these Day 2 certifying examinations, after which they will no longer be offered, leaving four Day 2 certifying examination options. The credentialing requirements are unchanged, and the certification remains in Zoological Medicine (large umbrella), not the individual focus areas. The recommended reading list for 2011 has been revised in accordance with the changes in the examination, and can be accessed at www.aczm.org.

Many factors affected the decision to make these changes, which were approved by a vote of the ACZM membership in 2009. Chief among these were two internal considerations: 1) to make the certifying examinations more discipline-based and less species-based, and 2) to make the examination administration process more manageable as the number of candidates continues to increase. The ACZM remains supportive of the American Board of Veterinary Practitioners' species-based model in Avian Practice, Reptile and Amphibian Practice, and Exotic Companion Mammal Practice, and considers the ACZM and ABVP certification routes to be complementary.

In order to become an ACZM Diplomate, one must have several years of professional experience in zoological medicine, be the primary author on at least 5 peer-reviewed publications, and successfully complete a two-day examination. A qualifying examination occurs on the first day, which includes the medicine of invertebrate, fish, avian, mammalian, amphibian and reptilian species. Candidates who pass the qualifying examination may take the certifying examination on a following day, in one of the following focus subjects: zoological companion animal (new in 2011), general zoo, wildlife, aquatic, avian, or amphibian/reptilian species. Successful candidates for Diplomate status must pass both the qualifying and certifying examinations.

Established in 1983, the American College of Zoological Medicine is an international specialty organization recognized by the American Veterinary Medical Association for certification of veterinarians with special expertise in zoological medicine. The ACZM is responsible for establishing training requirements, evaluating and accrediting training programs, and examining and certifying veterinarians in the veterinary specialty of zoological medicine. ACZM Diplomates serve in responsible positions as zoo and wildlife veterinarians, teachers, researchers, government officials, and administrators of other relevant programs fostering high quality medical care for non-domestic animals, and are actively involved in the discovery of new knowledge in the discipline and the dissemination of this knowledge to the veterinary profession and public.

# 2011 AQUAVET® I & II

The University of Pennsylvania School of Veterinary Medicine and the College of Veterinary Medicine at Cornell University are pleased to announce the 2011 AQUAVET® I & II Programs. They are aquatic veterinary medicine education programs that currently consist of two courses that will be presented this year at Roger Williams University in Bristol, RI in June 2011.

AQUAVET I: An Introduction to Aquatic Veterinary Medicine is a 4-week course (29 May - 24 June 2011) intended primarily for veterinary students.

AQUAVET II: Comparative Pathology of Aquatic Animals is a 2-week course (29 May - 10 June 2011) that is oriented toward the pathology of diseases of aquatic invertebrates and fish that are used in biomedical research, encountered in display aquaria and are of importance in commercial aquaculture.

Veterinary students can receive credits for the course and graduate veterinarians can receive CE credits. Applications for admission will be due by January 14, 2011 and may be obtained on the web site. Additional information may be found at www.aquavet.info.

# **Veterinary Internship**

The National Aquarium in Baltimore is offering a one-year veterinary internship in aquatic and zoo animal medicine. The collection includes over 16,000 animals (over 700 species of invertebrates, fresh and salt water fishes, amphibians, reptiles, birds, and mammals, including bottlenose dolphins).

The intern is integral to all aspects of animal medicine and surgery at the Aquarium. They provided training in physical examinations and sample collection, routine/quarantine/emergency medical treatment. diagnosis. radiology. disease anesthesia, surgery, gross necropsy, and clinical pathology of aquatic and zoo animals as well as professional communication within an aquarium setting. Interns have primary responsibility for daily management of Marine Animal Rescue Program stranded animals (typically 2-5 seals and 1-3 sea turtles annually). Interns are directly involved in teaching and supervising veterinary students. Interns are expected to produce 1 paper (case study/series or retrospective research) for publication in a peer-reviewed journal prior to leaving the program. In addition, the intern is responsible for two in-house staff training lectures. Opportunities exist for rotations at the Maryland Zoo in Baltimore or other facilities, as well as attending monthly resident/journal rounds at the Smithsonian's National Zoological Park and case rounds with the Maryland Zoo in Baltimore based on the interns' interest.

The veterinarians manage emergent cases and maintain active preventive medicine and quarantine programs based on AAZV and AZA guidelines. The veterinary team is composed of 3 clinicians (including the intern), two veterinary technicians, and 4 laboratory technicians managing water quality and clinical laboratory samples. The National Aquarium in Baltimore is a private, not-for-profit institution and is accredited by the Association of Zoos and Aquariums and has offered the internship since 1993. Prior interns have routinely obtained positions in the zoo or aquatic animal veterinary field and have obtained ACZM board certification.

Exceptional basic veterinary medical and surgical skills as well as familiarity with aquatic/zoo/exotic animal medicine are essential. The candidate should have demonstrated ability to work in a busy, multi-veterinarian practice with excellent oral and written (including computer-based medical records) communication skills. The candidate should have proven ability to teach veterinary students and exceptional medical record keeping skills.

#### Harbor Branch Oceanographic Institute Research Professor & Veterinary Scientist

Harbor Branch Oceanographic Institute (HBOI) at Florida Atlantic University (FAU) seeks a highly motivated, qualified senior veterinary scientist with research experience related to the health of marine mammal populations. This scientist will be at the full Research Professor level and will play a leadership role in further developing the research program and academic mission of the Marine Mammal Research and Conservation (MMRC) program at HBOI/FAU. The successful candidate will be expected to develop a strong research program with internal and external collaborators and to participate in clinical programs including health assessments and stranding and rehabilitation activities. She/he will mentor junior scientists and faculty, participate in training of MS and PhD candidates and post-doctoral fellows and lead degree and non-degree educational programs in marine mammal research on the HBOI/FAU campus.



The MMRC program contains a multidisciplinary group of faculty and staff scientists dedicated to the health and conservation of wild cetaceans and sirenians in the Indian River Lagoon (IRL) and coastal environment of Florida. The group consists of persons with expertise in clinical veterinary medicine, veterinary pathology, environmental epidemiology, biostatistics, public health, population ecology, genetics and environmental science. Efforts to enumerate and describe the Atlantic bottlenose dolphin population of the IRL were initiated in 1998 using photo-identification techniques. Subsequently, an extensive, indepth health assessment, the Bottlenose Dolphin Health and Environmental Risk Assessment Project, was undertaken with collaborating partners in 2003 and is ongoing. Important contributions have been made in the areas of emerging infectious diseases, the effects of environmental contaminants on health and

the role of the immune system in disease pathogenesis. The MMRC program also has active programs in outreach, public education and rehabilitation of stranded marine mammals that promote its mission to support ecosystem and marine mammal conservation.
