CALL FOR 2020 STUDENT TRAVEL AWARD APPLICATIONS

The IAAAM Executive Board will again be granting monetary awards to students planning to deliver **ORAL** presentations at the annual IAAAM conference in May 2020. The awards are intended to defray the cost of travel to the May 16-20th conference in Tampa, FL in order to promote student participation in the professional program and to further the commitment of the IAAAM to its students. Moneys will be awarded on a competitive basis, with the goal of supporting as many students as possible. Undergraduate students, Masters and PhD students, veterinary students, veterinary interns/residents/fellows, and postdocs are eligible. The requirements for all applicants include the following:

- 1. A cover letter that describes the future plans of the applicant with regard to aquatic animal medicine.
- 2. An abstract of the paper to be presented. This abstract <u>must not exceed 500 words</u> in length. Only abstracts will be considered. Abstracts must follow guidelines available on the IAAAM website: <u>www.iaaam.org</u>.
- 3. Curriculum vitae and two (2) letters of recommendation, one of which must be from an active member of the IAAAM.
- 4. An itemized budget that details the travel expenditures (i.e. airfare, lodging, meals, etc.) and indicates the funds available from student stipends and personal resources.
- 5. Student presenters must be an active member (with dues paid up-to-date) of the IAAAM, OR the student must provide a third, separate letter from the student's institution verifying student, intern/resident/fellow, or postdoc status. Students are <u>highly encouraged</u> to become active members of the IAAAM prior to submitting application. Student members are entitled to a lower conference registration rate than non-members.

The Education Member of the IAAAM Executive Board and the Student Liaison Committee will review the applications. Applicants will be ranked according to judgment criteria that will include: the quality of the written abstract (500 words or less), the justification/significance of the work, the complexity of the work relative to the student's academic achievements, and the commitment of the student to aquatic animal medicine. The intent of the Student Liaison Committee and the Executive Board is to fund as many students as possible, beginning with the highest ranked and continuing through the list of ranked applicants until the appropriated funds have been exhausted. No awards will exceed \$500.00. The rankings will be determined from the entire pool of applicants; separate awards for different academic classes of applicants (i.e. undergraduate, graduate, veterinary residents) will not be offered. There is one travel award designated for a deserving international applicant.

The deadline for receipt of complete application packets will be Sunday, <u>December 1, 2019</u>. Applications received after the deadline will not be considered. Recipients will be contacted by <u>February 1st, 2020</u>. Students submitting abstracts for the travel award competition must still separately submit their presentation abstract for acceptance into the conference proceedings. The IAAAM Treasurer will be notified and will send checks to the successful applicants.

Emailed applications will be accepted and are highly encouraged, though portions, such as letters of recommendation, may still be submitted by regular mail.

MEMBERSHIP DUES REMINDER

MEMBER SPOTLIGHTS

We are very excited to shine the spotlight on two exceptional facilities that conference attendees will have the opportunity to visit during the 51st annual IAAAM conference in Tampa, FL. The Florida Aquarium has been instrumental in the effort to save critical corals from extinction in Florida and Caribbean waters, while ZooTampa's David A. Straz, Jr. Manatee Critical Care Center has been rehabilitating and reintroducing manatees in Florida for nearly 30 years.

The Florida Aquarium has been an active participant in endangered Caribbean coral propagation for several years. In 2014, The Florida Aquarium, in conjunction with numerous non-profit and governmental partners, was the first to successfully spawn, settle, and grow staghorn coral (Acropora cervicornis). Building on this success, the 2018 spawning season resulted in the rearing and out-planting of more than 4,000 endangered corals of 4 different species, mostly staghorn and elkhorn coral, some of the key reef-building organisms in North America's largest barrier reef, the Florida Keys reef tract. The aquarium has also spent the past few years growing into a more critical, "rescue" role. 2014 saw the advent of a new, as yet unidentified, disease event known as stony coral tissue loss disease which resulted in the mortality of over 80% of more than 20 critically endangered stony corals species throughout the majority of the Florida reef tract. In response, state and federal agencies, along with a tremendous amount of support from partners including numerous AZA-accredited zoos and aquariums, launched the Florida Reef Tract Rescue Project with the audacious goal of rescuing and archiving more than 7,000 corals representing 15 of the most severely affected species. As one of the few strictly land-based coral aquaculture facilities in Florida, the aquarium has been instrumental in the development of techniques and expertise for successfully holding these species, some of which have never been successfully maintained in managed care. In a recent milestone, The Florida Aquarium successfully conditioned and triggered daytime spawning in endangered pillar coral (Dendrogyra cylindrus) - one of the earliest affected and most susceptible species which is now likely to be functionally extinct in its native Florida range. This was achieved by using a special booth termed Project Coral, developed by the Horniman Museum and allowing fine manipulation of temperature and photoperiod to cause coral to shift their spawning cycles. While "spawn on demand" is still a distant goal, the ability to start to control these events dramatically increases the ability to work with the corals and learn how different species reproduce. https://www.flaquarium.org/coral



ZooTampa's David A. Straz, Jr. Manatee Critical Care Center is the first non-profit, acute care facility of its kind specifically dedicated to critical care for wild manatees, and one of only four contracted, federally permitted, manatee rehabilitation centers in the state of Florida. Since 1991, the manatee care and veterinary teams have treated over 400 animals with more than 230 being reintroduced into Florida waters. With three false-bottom medical pools and two guest-facing holding systems, ZooTampa has the capacity to hold more than 20 rehabilitating manatees at any given time. In 2019, the center completed a more than \$3 million renovation and upgrade to the life support systems funded in part by a grant from the Florida Fish and Wildlife Conservation Commission which will allow them to continue to provide advanced care to manatees that have been orphaned, through affected by cold stress or red tide, or injured human interactions. https://zootampa.org/conserve/manatee/
